## MINUTES OF THE REGULAR MEETING January 12, 2010

### Call to Order, Minutes and Agenda:

Chairman. Barbara Bailey called to order the regular meeting of the Danville Election Commission at 9:00AM on Tuesday, January 12, 2010. Also present were Commissioners Charles Bostic and Everett Laury and Executive Director Barbara Dreher. The corrected proposed agenda to this January 12 meeting was unanimously approved. The minutes of the December 8, 2009 meeting were unanimously approved, with the addition that the proposed on-line training through the Attorney General website would include Election Commission employee Jennifer Klein and would also include training on the Freedom of Information Act.

### Accounts Payable:

Accounts payable in the total amount of \$2684.29 for the period of December 2, 2009 through January 6, 2010 were unanimously approved.

### Voter Registration:

Director Dreher reported 215 voter registrations for December 2009, with 128 being new registrations. There are now 17,328 registered voters in the city. Precinct 30 has the lowest number of 279 and precinct 17 has the highest number of 834.

### Election Matters:

Director Dreher reported no further information from the State's Attorney on the voter fraud complaint. The Director is awaiting receipt of the Primary Election Precinct Kits. Also changes are being made on the Federal ballots. The public test of the voting equipment is scheduled for 9:00AM on January 26, 2010. There was discussion of accessibility to the Courthouse Annex for the election due to the present construction work. The Election Commission will not use the Treasurer's office in this election due to space being available in the Commission's new offices. The Danville Civic Center will again be used for the posting of the election night returns. Also the Director reports that Military ballots have been mailed out.

### Other Matters:

Attention was called to the County Board meeting of January 14, 2010 on changes in the Freedom of Information Act. Comments were made on the good turnout for the Commission's 100<sup>th</sup> birthday Open House on December 12. Also despite the Commission's offices being open on December 26, 2009 and January 2, 2010 there were no new registrations on those days.

**Adjournment:**

The meeting was adjourned at 9:44AM. The next regular meeting is scheduled for 9:00AM on February 16, 2010.
