MINUTES OF REGULAR MEETING

January 13, 2009

Barbara Dreher
Executive Director

Call to Order:

Commissioner Barbara Bailey called the meeting to order on Tuesday, January 13, 2009 at 9:00AM at the office of the Commission. Present were Charles Bostic, Everett Laury, and Executive Director Barbara Dreher.

Minutes and Agenda:

The proposed agenda was unanimously approved. The minutes of the December 9, 2009 meeting were unanimously approved with an amendment that Director Dreher worked more than 120 hours overtime in preparation for the November election.

Accounts Payable:

Accounts payable for December in the amount of \$111.19 were approved. Also Director Dreher announced that the final cost of the November 2008 election was \$64,306.30

Voter Registration:

Total voter registrations for December 2008 was 117, of which 79 were new registrations and 25 were transfers. 7 registrations were rejected and reasons for the rejections were discussed.

HAVA Grant and 2008 Budget:

Director Dreher reported that of the HAVA Grant funds originally available to November 3, 2008, all but approximately \$26,000 had been spent, the latter balance being in the Phase II category. Also the board was given final totals for its budget for the 2007-08 fiscal year ending November 30, 2008, at which time \$18,704.83 unused budget funds were refunded to the County.

April 2009 Elections:

Barbara Dreher showed the Board petition and objection checklists to be given to candidates with their candidate packet prior to registration for future elections, in the hope that candidate errors and objections to nominating petitions can be lessened. Also Director Dreher will be giving schools for election judges prior to the April 2009 elections, concentrating on the use of affidavits by voters. Laptop computers have been loaned by the commission to the Democratic Party in Danville Township and to the Republican Party in Newell Township to aid in the checking of the registered voters at the Party Caucuses in those townships. There will be no primary election for the city of Danville. Also the Board discussed the use of the Ballot on Demand process for use at the April 2009 Elections.

Adjournment:

The meeting was adjourned at 10:20AM, with the next meeting scheduled for 9:00 AM on February 10, 2009.
