## MINUTES September 12, 2007

### Call to order

### Approval of Minutes

### Budget Update

Barbara Dreher reported that the Election Commission budget had passed the County Tax and E Committee and would go on to the Finance Committee for review. Unless there are questions of Finance Committee members, it will go on to the full County Board for approval.

### Training Update

Barbara Dreher stated that she has scheduled training sessions for herself on November 8<sup>th</sup> in Indianapolis and November 13<sup>th</sup> in Urbana. She is scheduling a power point class at DACC in October and is asking that E S & S send a representative to Danville to train herself, Jessica, Karen Rudd and Chris Millikin on the use of the ERM system.

Barbara Dreher updated the Commissioners on the State Association conference that she had attended in September in Aurora, Illinois.

Discussion was held regarding future grants available to Election Commissions.

The Commissioners and Executive Director also discussed possible early voter sites for the 2008 General Primary and General Election.
